6. Equity Subcommittee

Member Shockley (Equity Subcommittee Chair) presented the subcommittee's priorities for the upcoming year as:

- Discussion on extension of the provisional licenses for equity retailers, including Senator Bradford's SB 51;
- Develop a statewide definition for equity;
- Collect and analyze equity data;
- Discussion of subsidies for equity businesses, including taxation relief and access to grants, education, and other available resources.



Member Shockley presented the subcommittee's recommendation about the prioritization of equity programs and local jurisdictions that apply for the Local Jurisdiction Retail Access Grant. Discussion of the recommendations was held until Agenda Item #8.
