FINDINGS OF FACT

1. On or about August 16, 2024, Complainant Evelyn Schaeffer, in her official capacity as the Deputy Director of the Compliance Division of the Department of Cannabis Control, filed Citation No. DCC23-0001622-INV against Crescent Distribution Inc. (Respondent) with Scott John Van Horn as Owner (Owner) before the Department of Cannabis Control (Department). On or about November 20, 2025, Complainant filed Amended Citation No. DCC23-0001622-INV against Respondent before the Department. A true and correct copy of Amended Citation No. DCC23-0001622-INV is attached as Exhibit A.

2. On or about August 23, 2021, the Department issued Cannabis Retailer Non-Storefront License No. C9-0000447-LIC to Respondent. The Cannabis Retailer Non-Storefront

1 License expired on August 23, 2024, and has not been renewed. Pursuant to Business and
2 Professions Code section 26031, subdivision (d), the expiration in licensure does not deprive the
3 Department of its authority to institute or continue this disciplinary proceeding.

4 3. On or about August 16, 2024, Respondent was served with Citation
5 No. DCC23-0001622-INV.

6 4. On or about August 26, 2024, Respondent served a request for formal hearing
7 contesting Citation No. DCC23-0001622-INV.

8 5. On or about November 20, 2025, Respondent was served with Amended Citation
9 No. DCC23-0001622-INV, which was deemed controverted by Respondent's previous request
10 for formal hearing.

11 6. On November 21, 2025, a Notice of Hearing was served by certified mail and by
12 first-class mail at Respondent's address of record which was and is: 1189 Pike Ln.,
13 Oceano, CA 93445-9477. The Notice of Hearing was also served by certified mail and by first-
14 class mail at Respondent's address with the California Secretary of State which is 5063 North
15 Van Ness Blvd., Fresno, CA 93711. The Notice of Hearing informed Respondent that an
16 administrative hearing in this matter was scheduled for December 9, 2025.

17 7. Service of the Citation, and of the Amended Citation, was effective as a matter of law
18 under the provisions of Government Code section 11505(c) and/or Business and Professions
19 Code section 124.

20 8. On December 9, 2025, the matter was called for hearing at the time and location set
21 forth in the Notice of Hearing. The assigned Administrative Law Judge found that the service of
22 the Notice of Hearing on Respondent was proper. There was no appearance by, or on behalf of,
23 Respondent. A default was declared and on motion of counsel for Complainant, the matter was
24 remanded to the Department under Government Code section 11520.

25 9. Government Code section 11506(c) states, in pertinent part:

26 (c) The respondent shall be entitled to a hearing on the merits if the respondent
27 files a notice of defense . . . and the notice shall be deemed a specific denial of all
28 parts of the accusation . . . not expressly admitted. Failure to file a notice of defense
shall constitute a waiver of respondent's right to a hearing, but the agency in its
discretion may nevertheless grant a hearing.

10. California Government Code section 11520(a) states, in pertinent part:

(a) If the respondent either fails to file a notice of defense . . . or to appear at the hearing, the agency may take action based upon the respondent's express admissions or upon other evidence and affidavits may be used as evidence without any notice to respondent

11. Pursuant to its authority under Government Code section 11520, the Department finds Respondent is in default. The Department will take action without further hearing and, based on the relevant evidence contained in the Default Decision Investigatory Evidence Packet in this matter, finds that the charges and allegations in Amended Citation No. DCC23-0001622-INV, are separately and severally, found to be true and correct by clear and convincing evidence.

12. The Department finds that the actual costs for Investigation and Enforcement are \$9,070.25 as of December 3, 2025.

DETERMINATION OF ISSUES

1. Based on the foregoing findings of fact, Respondent Crescent Distribution Inc with Scott John Van Horn, Owner has subjected its Cannabis Retailer Non-Storefront License No. C9-0000447-LIC to the citation and fine set forth in Amended Citation No. DCC23-0001622-INV.

2. Service of Amended Citation No. DCC23-0001622-INV and related documents were proper and in accordance with the law.

3. The agency has jurisdiction to adjudicate this case by default.

Violation 1. Failure to Comply with Video Surveillance Requirements

CCR, title 4, section 15044, subdivision (h) requires that surveillance recordings shall be kept for a minimum of 90 calendar days. CCR, title 4, section 15044, subdivision (i) states that surveillance recordings are subject to inspection by the Department and shall be kept in a manner that allows the Department to view and obtain copies of the recordings at the licensed premises immediately upon request. The licensee shall also send or otherwise provide copies of the recordings to the Department upon request within the time specified by the Department.

On October 4th, 2023, a field inspection took place at the licensed premises of Crescent Distribution Inc. During the inspection, the licensee was unable to provide evidence of surveillance recordings for 90 calendar days. On October 17th, 2023, a Notice to Comply was issued to Crescent Distribution Inc. requiring the licensee to correct the violation. The Notice to Comply was served to the licensee by Certified Mail and by email, and due back to the Department on November 16th, 2023. The licensee failed to respond to the Notice to Comply or provide evidence of the correction. As a result, the licensee violated the requirements of BPC section 26070 and CCR, title 4, section 15044 subdivisions (h) and (i).

Violation 2. Failure to Comply with Package Tag Requirements

CCR, title 4, section 15048.5, subdivision (c) requires that for all cannabis and cannabis products held in a container, the package tag shall be affixed to the container holding the cannabis or cannabis products. If cannabis or cannabis products are held in multiple containers, the package tag shall be affixed to one of the containers and the other containers shall be labeled with the applicable UID number. Each unit within the container shall be labeled with the applicable UID number. All containers with the same UID number shall be placed contiguous to one another to facilitate identification by the Department.

On October 4th, 2023, a field inspection took place at the licensed premises of Crescent Distribution Inc. During the inspection, cannabis and cannabis products stored in a container did not have the package tag affixed to each container or labeled with applicable UID numbers. On October 17th, 2023, a Notice to Comply was issued to Crescent Distribution Inc. requiring the licensee to correct the violation. The Notice to Comply was served to the licensee by Certified Mail and by email, and due back to the Department on November 16th, 2023. The licensee failed to respond to the Notice to Comply or provide evidence of the correction. As a result, the licensee violated the requirements of BPC section 26067 and CCR, title 4, section 15048.5 subdivision (c).



Violation 3. Failure to Comply with Delivery License Requirements

CCR, title 4, section 15415, subdivision (f) requires that a delivery employee of a licensed retailer shall, during deliveries, carry a copy of the retailer's current license, a copy of the QR Code Certificate issued by the Department, which complies with section 15039, subsection (d), the employee's government-issued identification, and an identification badge provided by the employer pursuant to section 15043. A delivery employee shall provide a copy of the retail license, a copy of the QR Code Certificate, and their employee identification badge to a delivery customer upon request.

Violation 4. Failure to Comply with Delivery Track and Trace Requirements

CCR, title 4, section 15049.3, subdivision (c) requires that for each delivery of cannabis goods, the following information shall be recorded within the track and trace system by the end of the calendar day on which the delivery was completed: (1) The date and time the delivery was completed. A delivery is completed at the time the cannabis goods are physically provided to the customer. (2) Whether the customer is an adult-use customer, medicinal cannabis patient, or patient's primary caregiver. (3) The UID and quantity of each cannabis good delivered. (4) The purchase price of each cannabis good delivered. (5) The city, county, and zip code in which the delivery was

On October 4th, 2023, a field inspection took place at the licensed premises of Crescent Distribution Inc. After reviewing the Delivery Inventory Ledgers in the licensee's Track and Trace system, it was determined that the ledgers were not being completed with all the necessary information as required. On October 17th, 2023, a Notice to Comply was issued to Crescent Distribution Inc. requiring the licensee to correct the violation. The Notice to Comply was served to the licensee by Certified Mail and by email, and due back to the Department on November 16th, 2023. The licensee failed to respond to the Notice to Comply or provide evidence of the correction. As a result, the licensee violated the requirements of BPC section 26067 and CCR, title 4, section 15049.3 subdivision (c).

Violation 5. Failure to Comply with Notice to Comply Requirements

CCR, title 4, section 17801, subdivision (d) states that the licensee shall sign and return the Notice to Comply and describe how compliance was achieved within 30 calendar days after the date of personal service or the date of emailing or mailing of the notice or a different date specified by the Department. The Department may also require the licensee to provide a plan for review and approval by the Department on a case-by-case basis.

On October 17th, 2023, the Department issued a Notice to Comply to Crescent Distribution Inc. for violations observed during a field inspection on October 4th, 2023. The Notice to Comply was served to the licensee by Certified Mail and by email, and due back to the Department on November 16, 2023. On December 26th, 2023, the Department emailed Crescent Distribution Inc. a Letter of Warning advising them to respond to the Notice to Comply. Crescent Distribution Inc. responded to the email advising that the company went out of business on October 31st, 2023, when they vacated their leased unit, and did not submit the Notice to Comply. As a result, the Licensee failed to comply with the Department's October 17th, 2023, Notice to Comply and violated the requirements of BPC section 26030 and CCR, title 4, section 17801 subdivision (d).

Requesting an informal conference does not stay or toll the running of the 30-day period for you to request a formal hearing to contest the citation before an Administrative Law Judge. You should request an informal conference as soon as possible if you would like to allow time to hold the conference prior to the deadline for contesting the citation as the time to contest a citation does not stop if you request an informal conference.

At the conclusion of the informal conference, a written decision stating the reasons for the decision will be mailed to you within 15 calendar days from the date of the informal conference, which shall be deemed a final order. If the citation is dismissed, any request for a formal hearing shall be deemed withdrawn. If the citation is affirmed or modified, you may either withdraw the request for a formal hearing or proceed with the hearing. If cannabis or cannabis products are held in multiple containers, the package tag shall be affixed to one of the containers and the other containers shall be labeled with the applicable UID number. Each unit within the container shall be labeled with the applicable UID number. All containers with the same UID number shall be placed contiguous to one another to facilitate identification by the Department.

On October 4th, 2023, a field inspection took place at the licensed premises of Crescent Distribution Inc. During the inspection, cannabis and cannabis products stored in a container did not have the package tag affixed to each container or labeled with applicable UID numbers. On October 17th, 2023, a Notice to Comply was issued to Crescent Distribution Inc. requiring the licensee to correct the violation. The Notice to Comply was served to the licensee by Certified Mail and by email, and due back to the Department on November 16th, 2023. The licensee failed to respond to the Notice to Comply or provide evidence of the correction. As a result, the licensee violated the requirements of BPC section 26067 and CCR, title 4, section 15048.5 subdivision (c).



Violation 3. Failure to Comply with Delivery License Requirements

CCR, title 4, section 15415, subdivision (f) requires that a delivery employee of a licensed retailer shall, during deliveries, carry a copy of the retailer's current license, a copy of the QR Code Certificate issued by the Department, which complies with section 15039, subsection (d), the employee's government-issued identification, and an identification badge provided by the employer pursuant to section 15043. A delivery employee shall provide a copy of the retail license, a copy of the QR Code Certificate, and their employee identification badge to a delivery customer upon request.

Violation 4. Failure to Comply with Delivery Track and Trace Requirements

CCR, title 4, section 15049.3, subdivision (c) requires that for each delivery of cannabis goods, the following information shall be recorded within the track and trace system by the end of the calendar day on which the delivery was completed: (1) The date and time the delivery was completed. A delivery is completed at the time the cannabis goods are physically provided to the customer. (2) Whether the customer is an adult-use customer, medicinal cannabis patient, or patient's primary caregiver. (3) The UID and quantity of each cannabis good delivered. (4) The purchase price of each cannabis good delivered. (5) The city, county, and zip code in which the delivery was

On October 4th, 2023, a field inspection took place at the licensed premises of Crescent Distribution Inc. After reviewing the Delivery Inventory Ledgers in the licensee's Track and Trace system, it was determined that the ledgers were not being completed with all the necessary information as required. On October 17th, 2023, a Notice to Comply was issued to Crescent Distribution Inc. requiring the licensee to correct the violation. The Notice to Comply was served to the licensee by Certified Mail and by email, and due back to the Department on November 16th, 2023. The licensee failed to respond to the Notice to Comply or provide evidence of the correction. As a result, the licensee violated the requirements of BPC section 26067 and CCR, title 4, section 15049.3 subdivision (c).

Violation 5. Failure to Comply with Notice to Comply Requirements

CCR, title 4, section 17801, subdivision (d) states that the licensee shall sign and return the Notice to Comply and describe how compliance was achieved within 30 calendar days after the date of personal service or the date of emailing or mailing of the notice or a different date specified by the Department. The Department may also require the licensee to provide a plan for review and approval by the Department on a case-by-case basis.

12 persons have also performed tasks related to this matter: Harinder K. Kapur, Senior Assistant
13 Attorney General; and Helen Koh, Paralegal.

14 4. I am familiar with the time recording and billing practices of DOJ and the procedure
15 for charging the client agency for the reasonable and necessary work performed on a particular
16 case. It is the duty of the time keeping employees to keep track of the time spent and to report
17 that time in DOJ's computerized case management system at or near the time of the tasks
18 performed.

19 5. On December 4, 2025, I requested a billing summary for this case from the
20 Accounting Department of the DOJ. In response, on December 4, 2025, I received a document
21 entitled "Matter Time Activity by Professional Type." I hereby certify that the Matter Time
22 Activity by Professional Type, attached hereto as Exhibit A, and herein incorporated by
23 reference, is a true and correct copy of the billing summary for this matter that I received from the
24 Accounting Department. The summary includes the billing costs incurred by me, as well as other
25 professionals of the DOJ who worked on the matter; and sets forth the tasks undertaken, the
26 amount of time billed for the activity, and the billing rate by professional type. The billing
27 summary is comprehensive of the charges by the Office to the Department of Cannabis Control

1 through December 3, 2025. It does not include billing for tasks performed after December 3,
2 2025, up to the date of hearing.

3 6. Based upon the time reported through December 3, 2025, as set forth in Exhibit A,
4 DOJ has billed the Department of Cannabis Control \$6,521.25 for the time spent working on the
5 above-entitled case.

6 7. To the best of my knowledge the items of cost set forth in this certification are correct
7 and were necessarily incurred in this case.

SUMMARY

On October 4th, 2023, I, Department of Cannabis Control (DCC) Special Investigator (SI) Samantha Lehnhoff, assisted with an announced inspection of Crescent Distribution Inc., (C9-0000447-LIC) at the request of the San Luis Obispo County Sheriff's Office (SLOSO) Cannabis Compliance Team. After the inspection, the licensee failed to respond to the issued Notice to Comply (NTC) within 30 days, in violation of §17801(d).

On December 7th, 2023, I received photographs from Resource Protection Specialist III Sarah Anderson with the SLOSO's Cannabis Compliance Team (Anderson) via email providing evidence that the licensed premises has been vacated without any coinciding manifests within the Track and Trace system, in violation of §15000.7(a) and §15049.2(a).

On December 26th, 2023, I issued a Letter of Warning to Crescent Distribution Inc., giving them 10 days to respond to questions regarding the status of their active retail license. Crescent Distribution Inc. failed to respond to the associated questions within the given time frame.

BACKGROUND

On September 27th, 2023, I received a call from Anderson. She advised that she was having issues with Crescent Distribution Inc. failing to comply with properly applying package tags to cannabis products, per §15048.5(c). She advised that she believed all the product was legally obtained but that the licensee, Scott John Van Horn, refuses to comply or doesn't understand the regulatory requirement. We planned a joint inspection of the licensed premises on October 4th, 2023.

CASE NARRATIVE

On October 4th, 2023, at approximately 12:00 pm, I, Department of Cannabis Control (DCC) Special Investigator (SI) Samantha Lehnhoff, conducted a field inspection of Crescent Distribution Inc. (licensee) (C9-0000447-LIC) located at 1189 Pike Ln, Suite 5, Oceano, CA. Crescent Distribution Inc. is a Non-storefront Cannabis Retail Dispensary with an active license that expires on August 23rd, 2024. Also present were SLOSO's Cannabis Compliance Team staff Anderson and Detective Michael DeRose, and DCC SI Mason Sperakos (Sperakos). On site, we met with the Owner Applicant, Scott John Van Horn (Van Horn). This inspection was set up by Anderson via a phone call with Van Horn.

We inspected the licensed premises with Van Horn and discovered four (4) violations. Van Horn was unable to provide surveillance recordings at the time of inspection, in violation of §15044(i). Van Horn did not provide evidence of 90 days of surveillance video storage, in violation of §15044(h). Van Horn was unable to login to his surveillance system at the time of inspection. Cannabis and cannabis products stored in a container did not have the package tag affixed to each container or labeled with applicable UID numbers, in violation of §15048.5(c). I explained the package tag expectation to Van Horn who advised that he understood. The copy of Crescent Distribution Inc.'s retailer license that is required to be in the delivery vehicle during deliveries expired on August 23rd, 2023, in violation of §15415(f). (**Attachment A**) I did not discuss the expired retailer's license at that time with the licensee, as it was noticed by my partner, Sperakos, who advised me after initially finding the violation. We concluded the inspection and left the licensed premises at approximately 1:30 pm.

On October 5th, 2023, I conducted a search of Crescent Distribution Inc.'s METRC account, noting that their Retail Delivery Ledgers appeared incomplete. I contacted the Department's subject matter experts, the California Cannabis Track and Trace (CCTT) Team, and requested they evaluate Crescent Distribution Inc.'s Retail Delivery Ledgers. CCTT advised via email (**Attachment B**) that after reviewing Crescent Distribution Inc.'s METRC account, they are not properly completing the ledgers, as required by §15049.3(c). I added §15049.3(c) to the Notice to Comply (NTC), requiring them to complete Retail Delivery Ledgers.

On October 17th, 2023, I issued an NTC to Crescent Distribution Inc. (**Attachment C**) The NTC was served to the licensee by Certified Mail at 5063 North Van Ness Blvd, Fresno, CA 93711 by DCC Analyst Ian Halligan (**Attachment D**) and sent by email to crescentdistributioninc@gmail.com by me on October 17th, 2023. (**Attachment E**)

I reviewed the contact address, email address, and phone number provided by the licensee and listed in Crescent Distribution Inc.'s Accela licensing file and observed that the mailing address listed for Owner Applicant and Primary Contact, Van Horn, is 5063 North Van Ness Blvd., Fresno, CA 93711 and the provided email address is crescentdistributioninc@gmail.com. I observed that the primary phone number listed for Van Horn is (559) 213-1331. (**Attachment F**)

I then reviewed the email address to which the NTC email was sent and confirmed that it was emailed to crescentdistributioninc@gmail.com. I also reviewed the mailing address to which the NTC was mailed Certified Mail and confirmed it was mailed to 5063 North Van Ness Blvd., Fresno, CA 93711.

On November 14th, 2023, I emailed Van Horn at crescentdistributioninc@gmail.com inquiring if he needed any assistance with the NTC or completing the required Table B and reminded him that it was due back to me on November 16th, 2023. (**Attachment G**)

On November 16th, 2023, I had not heard back from Van Horn regarding the NTC. I called his primary phone listed in DCC's Accela records, (559) 213-1331, and got no answer, I left a message. I called Crescent Distribution Inc.'s business phone number listed in DCC's Accela records, (844) 427-3723, but the call could not be connected. (**Attachment H**) I emailed Anderson asking her to have Van Horn contact me if she speaks with him. (**Attachment I**)

As of November 22nd, 2023, I still had not heard back from Van Horn. I emailed him again, at crescentdistributioninc@gmail.com, advising him that the NTC was now late and that he needed to contact me immediately to address it to ensure that his license remains compliant. (**Attachment J**) I again called the provided primary contact phone number, (559) 213-1331, and left him the same message. The provided phone number listed for the business, (844) 427-3723, was still not connecting.

On November 27th, 2023, Anderson emailed me to tell me that she had received information that Van Horn had recently moved from the licensed premises, possibly with all his cannabis products.

(**Attachment K**) On November 28th, 2023, Anderson advised me via email (**Attachment L**) that she had spoken to Van Horn's licensed premises property manager, Mazen Shaalan, (**Attachment M**) who told her that he issued Van Horn an unlawful detainer and Van Horn surrendered the unit the same day. Anderson was planning to respond to the licensed premises the same week for photographic documentation.

I emailed Van Horn on November 28th, 2023, at an additional email address that I located in Crescent Distributions Inc.'s METRC account, sivanhorn@sbcglobal.net, (**Attachment N**) advising Van Horn to contact me immediately regarding the late NTC. (**Attachment O**)

On December 7th, 2023, Anderson called me to advise me that she had visited the licensed premises and Van Horn had vacated the location. She emailed me two separate emails titled "Unit Vacated and Product Removed" (**Attachment P**) (**Attachment Q**) that included photographs of the abandoned unit. (**Attachment R**) Anderson told me via phone that the landlord served Van Horn a pay or quit notice as he owed approximately \$17,000.00 in unpaid rent, which Anderson emailed me a copy of on December 19th, 2023. (**Attachment S**)

On December 8th, 2023, I called Van Horn's provided primary contact phone number, (559) 213-1331, and got no answer, I left a message requesting he return my call. As of this date and continuing Crescent Distribution Inc.'s METRC account shows 326 active packages and zero outgoing manifests for the history of this license that would document coinciding manifests and show evidence of a lawful

transfer of cannabis from the licensed premises. (**Attachment T**)

On December 19th, 2023, Anderson advised me via email (**Attachment U**) that SLOSO's Cannabis Compliance Team is in the process of speaking to the County Council and the tax office on what steps they will be taking regarding Crescent Distribution Inc.'s county business license status, regarding either a non-renewal or revocation.

On December 26th, 2023, I emailed Van Horn a Letter of Warning (LOW) outlining violations §17801(d), §15000.7(a), and §15049.2(a). (**Attachment V**) I confirmed that it was emailed to both email addresses identified for Van Horn, crescentdistributioninc@gmail.com and sivanhorn@sbcglobal.net. It required a written response by January 10th, 2024. (**Attachment W**)

Van Horn responded to my email containing the LOW from sivanhorn@sbcglobal.net, the email provided within his employee login in Crescent Distribution Inc's METRC account. He advised that he went out of business on October 31st, 2023, when they moved out of their leased unit. He advised that the landlord would not negotiate a reasonable rent and he was having issues with a downstairs neighbor. I responded to his email requesting that he still respond to the violations outlined in the LOW. (**Attachment X**)

On January 2nd, 2024, I emailed DCC Licensing to inquire what information was needed, beyond a confirmed email from the licensee stating that the business is closed, to begin the revocation process. Janet Zimmer, Staff Services Manager I with the Licensing Division (Zimmer), responded via email that the licensee is currently a provisional licensee under environmental review, and they are pending transition to an annual license. Zimmer also advised that nothing is preventing the Department from pursuing a license revocation but suggested that I concurrently request denial of the annual application as well. (**Attachment Y**)

On January 3rd, 2024, I received an email from Anderson advising that "as of 12/22/2023, Crescent Distribution no longer has a business license and cannot operate the cannabis business in SLO County." I inquired with her about whether the County plans to take further action towards him (Van Horn) and if so, what the appeals period may look like. Anderson advised that "his business license is done as it expired a while back and he made no attempt to pay or renew it. There isn't an appeal period given for this as it's technically not a denial or revocation" (**Attachment Z**) She included an attachment from San Luis Obispo County that shows that Crescent Distribution Inc.'s business license authorization period ended on October 31st, 2023. (**Attachment AA**)

I have not heard further from Crescent Distribution Inc.'s owner applicant, Scott Van Horn.


