

19 The Department deems Respondent's December 24, 2025, email a request to vacate the
20 Department's Default Decision and Order, dated December 18, 2025. The Department has
21 considered the Complainant's and Respondent's submissions. Complainant's service of the
22 Notice of Hearing by certified mail to Respondent's address of record on file with the
23 Department satisfied the due process obligation to provide notice reasonably calculated to
24 apprise Respondent of the impending hearing. (*GC Brothers Entertainment LLC v.*
25 *Department of Alcoholic Beverage Control ("GC Brothers")* (2nd Dist. 2022) 84 Cal.App.5th
26 1019, 1030.) However, the Administrative Procedures Act also allows the Department to
27 grant relief from default for good cause, including Respondent's failure to receive notice.
28 (Gov. Code, § 11520, subd. (c); see *GC Brothers*, 84 Cal.App.5th at p., 1032-1033.)

1 The Department finds that Respondent has established good cause, and hereby
2 ORDERS that the Department's December 18, 2025, Default Decision and Order be vacated.

3 This Order shall become effective on January 16, 2026.


